- **Purpose:** To offer a more tailored experience and improve user interaction with the Website.

2.4. Advertising and Targeting Cookies

- **Description:** These cookies are used to display advertisements that are relevant to you and your interests. They may also limit the number of times you see an ad and help measure the effectiveness of advertising campaigns.

- **Purpose:** To show content and advertisements tailored to your preferences and browsing habits.
