

# **TEISOFT PRIVACY NOTICE**

At **Teisoft, LLC** ("**Teisoft**"), we are committed to protecting your privacy and responsibly handling your personal data. This Privacy Notice outlines how we collect, use, disclose, and protect your personal information when you interact with us through our website, services, or any other form of communication.

### 1. Who We Are

Teisoft, LLC, located at **1590 Harbour Side Dr, Weston, FL 33326, USA**, is the entity responsible for the processing of your personal data.

### 2. Information We Collect

### 2.1. Personal Data You Provide
